# **RECOMMENDATIONS**

- 1. The catalyst level should not exceed 2.8% or fall below 1% for proper cure.
- 2. These products should not be used when temperature conditions are below 16°C, as curing and handling may be adversely affected.
- 3. Do not add any material different to the catalyst recommended for these products.
- 4. Do not mix organic peroxides with metallic soaps, amines or any type of accelerators or promoters, because it can result on violent decomposition with fire or explosion.

#### **STORAGE**

Uncatalyzed PTM-8587 and PTM-8588H resins, have a usage life of three months from invoice date, when stored at 25°C or below, in a closed, factory sealed opaque containers, and out of direct sunlight, heat sources or moisture. For every 7°C increase in storage temperature, the shelf life is reduced by one half.
